

RESOLUTION NUMBER R-255083

Adopted on SEP 29 1981

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the street easement has a width in excess of the public street needs; and

WHEREAS, the abutting property owner has requested the vacation of a portion of Cardeno Drive adjacent to Lots 22 through 24 of La Jolla Alta PRD Units 9 and 10, Map 8948; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That portion of Cardeno Drive adjacent to Lots 22 through 24 of La Jolla Alta PRD Units 9 and 10, Map 8948, as more particularly shown on Drawing No. 15072-B on file in the office of the City Clerk as Document No. RR-255083-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

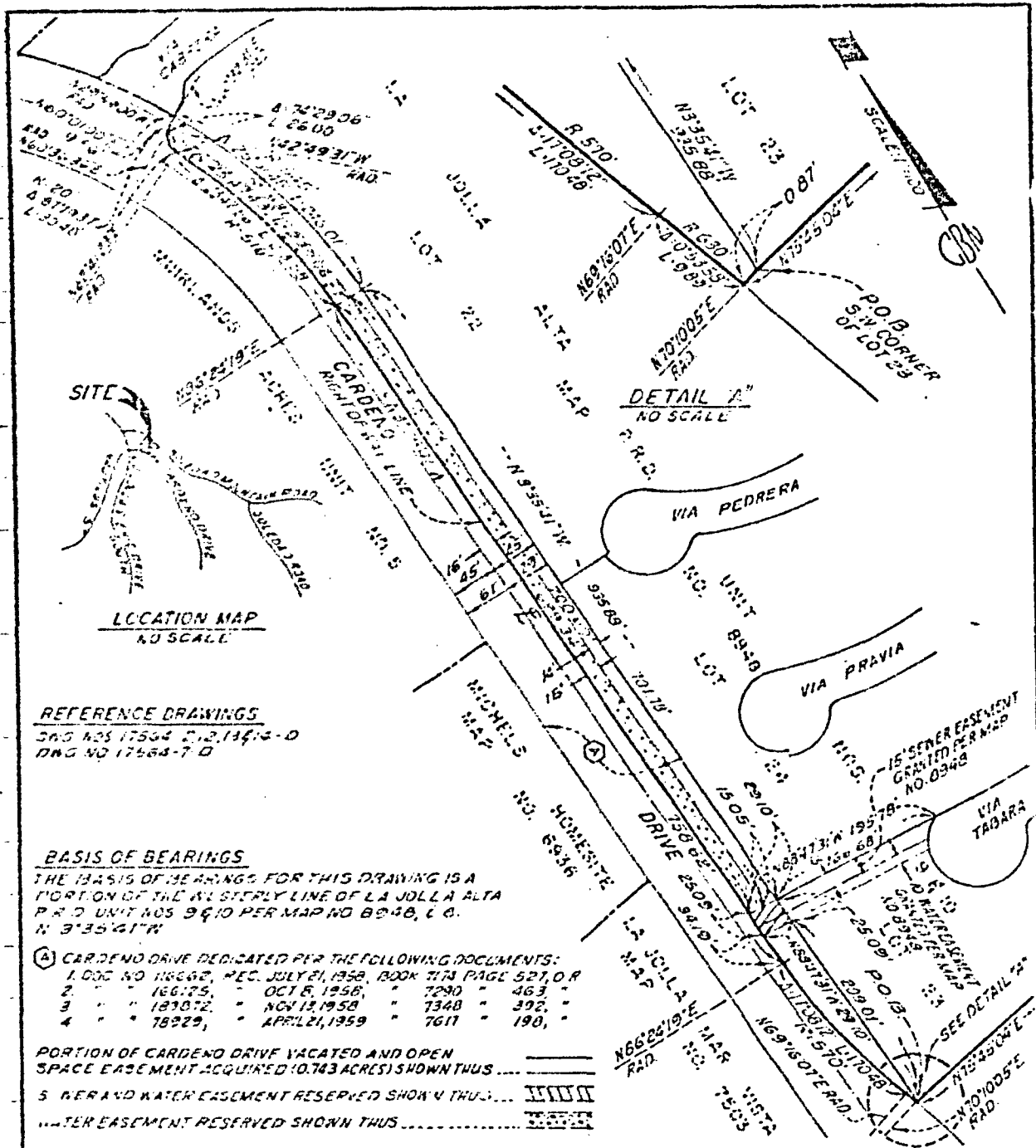
2. That the sewer and water easements in a portion of Cardeno Drive as more particularly shown on Drawing No. 15072-B are hereby reserved.
