
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute an agreement with TRW, INC., an OHIO CORPORATION pursuant to which TRW, Inc., shall perform certain initial site preparations related to the development of Lot 6 of Campus Point Industrial Park, and the City will provide for expanded electrical capacity and reimburse TRW, Inc., in the amount of \$1,400; and in addition the City will reimburse TRW, Inc., in an amount not to exceed \$14,500 from anticipated future receipts of funds from the San Diego Gas and Electric Co., under the terms and conditions in that agreement, a copy of which is on file in the office of the City Clerk as Document No. RR -255088.

BE IT FURTHER RESOLVED, that the expenditure not to exceed \$1,400 from the Industrial Development Fund 30244, pursuant to the terms of the above agreement together with not to exceed \$14,500 from future reimbursements from the San Diego Gas and Electric Company, is hereby authorized.
