WHEREAS, certain potential environmental impacts have been identified in connection with the proposed development of the Mission Bay Ramada Hotel; and

WHEREAS, all identified potential adverse impacts are capable of being mitigated as specified in Conditional Negative Declaration No. 80-08-34; and


WHEREAS, the proposed developer and operator of the hotel has agreed to take actions necessary to mitigate such impacts if the City proceeds with execution of a hotel lease; and

WHEREAS, all mitigation measures will be enforced through the terms of the lease agreement as well as through the City's control over development and through conditions which would be imposed on any land development permit; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego follows:

That it be, and it is hereby certified, that the information contained in CONDITIONAL NEGATIVE DECLARATION NO. 80-08-34 in connection with Mission Bay Ramada Hotel, on file in the office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970, as amended, and the State guidelines thereto, and that said Declaration has been reviewed and considered by this Council.
