WHEREAS, with the approval of the final map of RANCHO BERNARDO TECHNOLOGY PARK subdivision, the City shall receive easement interests which allow the quitclaim of the existing sewer easement within the subdivision; and


WHEREAS, the City Manager has certified that the easement interests to be exchanged are approximately equal in value; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 255172-1, quitclaiming to American Property Investors VIII, a California limited partnership, all the City's right, title and interest in the sewer easement, as more particularly described in said quitclaim deed.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
