That the acceptance by the City Manager of that easement deed of the United States of America, Department of the Navy, executed in favor of The City of San Diego, bearing date of June 19, 1981, a copy of which is on file in the office of the City Clerk as Document No. RR- 255175, granting to said City an easement for sewage purposes across portions of Pueblo Lots 33, 34, 62, 67, 68 101, 105 and 106 (United States Naval Supply Center and United States Naval Ocean Systems Center), as more particularly described in said deed, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$90,872.00 within the Sewer Revenue Fund (41506) from the Unallocated Reserve (70697) to CIP-46-037, Point Loma Sludge Line Replacement (70292, Wastewater Construction Outlay).

BE IT FURTHER RESOLVED, that the expenditure not to exceed \$90,872.00 from the Sewer Revenue Fund (41506), CIP 46-037, Point Loma Sludge Line Replacement is hereby authorized and approved.

That the City Clerk is hereby authorized and directed to forward said deed and a certified copy of this resolution attested by him under seal to the Property Department for further handling.
