


RESOLUTION No. R- 255176 (R-81-1849 )

Adopted on OCT 12 1981

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of the City of San Diego, a Permit granting to the STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION, (CALTRANS) the nonexclusive right to extract decomposed granite road building materials, not to exceed 500,000 cubic yards, from the Crane's Peak Borrow Pit site, during the five (5) year period following the date of said permit agreement, at a consideration to City of \$0.75 for each cubic yard of material removed from the site or \$1,500 per year, whichever is the greater amount, under the terms and conditions set forth in that Permit on file in the office of the City Clerk as Document No. RR-255176.
