
RESOLUTION CONSIDERING THE PROTESTS, ORDERING THE DISTRICT FORMED, CONFIRMING THE ASSESSMENT AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF THE IMPROVEMENT OF FAIRMOUNT AVENUE BETWEEN TWAIN AVENUE AND VANDEVER AVENUE.

WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of the improvement of FAIRMOUNT AVENUE between Twain Avenue and Vandever Avenue under Resolution of Intention No. R-251898, adopted May 27, 1980, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The protests, if any, are overruled.
2. The District, the boundaries of which are described in said Resolution of Intention, is hereby ordered formed.
3. The assessments described in Document No. D-02215-1 on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved.
4. The maintenance described in said Resolution of Intention is hereby ordered performed.
