BE IT RESOLVED, by the Council of The City of San Diego, as follows:



WHITWER, an individual for the CONSTRUCTION OF FIRE STATION NO. 16 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. A-00245.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$57,526.00 from the Capital Outlay Unallocated Reserve Fund 90-245 to Capital Outlay Fund 30245, CIP 33-064, Construction of Fire Station No. 16.

3. That the expenditure, not to exceed \$57,526.00 from Capital Outlay Fund 30245, CIP 33-064, Construction of Fire Station No. 16 of the City of San Diego is hereby authorized to supplement funds previously authorized by Resolution No. R-254783, adopted August 10, 1981 for the purpose of executing this contract and related costs.
