APPROVING MAP OF BELLA PACIFIC PARK AND ACKNOWLEDGING
RECEIPT OF SUBDIVIDER'S ASSURANCE OF COMPLIANCE WITH THE
AFFIRMATIVE MARKETING PROGRAM

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by E. F. COOK, a Registered Civil Engineer, entitled "BELLA PACIFIC PARK Being a subdivision of a portion of Lot 1 of Rose Terrace Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 3537 filed in the office of the County Recorder of San Diego County, November 1, 1956, together with a portion of Pacifica Drive as being closed and vacated to public use, together with Lot 116 of Pacifica, all in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 4588, filed in the office of the County Recorder of San Diego County, July 15, 1960.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1, 2, 3, and 4 of the owner's certificate, as shown on this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that those easements listed in paragraphs 1, 2, 3, and 4 of the owner's certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, BELLA PACIFIC PARK, a limited partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the Office of the City Clerk, and in reliance on said assurance does hereby accept the final map of BELLA PACIFIC PARK.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
