

RESOLUTION NUMBER R- 255224

Adopted on OCT 26 1981

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the street to be vacated is excess width right-of-way not required for street purposes; and

WHEREAS, that portion of PACIFICA DRIVE is excess width right-of-way for street purposes; and

WHEREAS, those properties adjoining that portion of PACIFICA DRIVE to be vacated will continue to have access or will be accessible by the existing streets and the lots being created with the approval on this date of the subdivision to be known as BELLA PACIFIC PARK; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

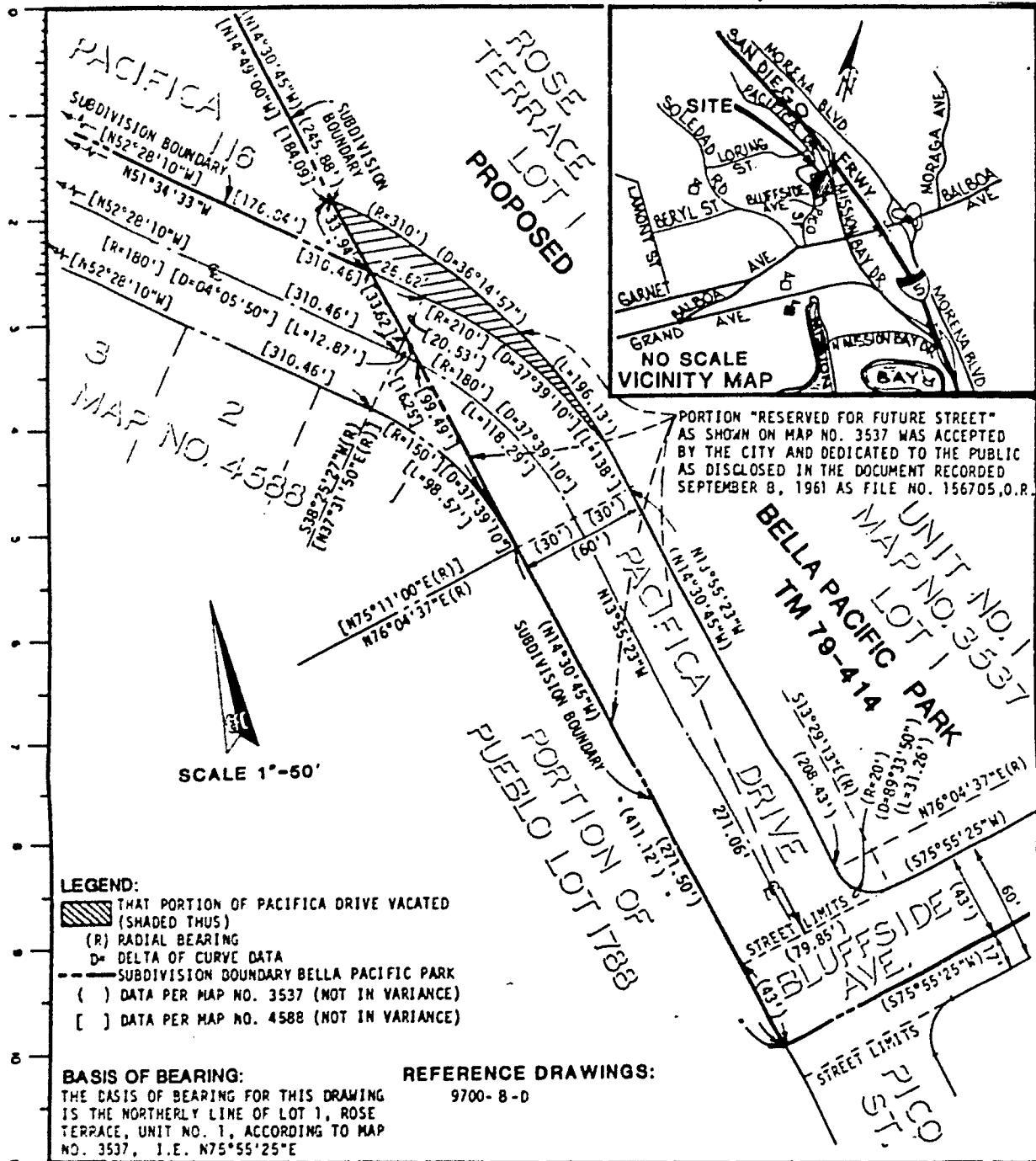
1. That a portion of PACIFICA DRIVE, as more particularly shown on Drawing No. 15338-B on file in the office of the City Clerk as Document No. RR-255224-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder. RR-255224-2
