

RESOLUTION NUMBER R- 255230


Adopted on OCT 26 1981

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and drainage easement deeds of GENSTAR DEVELOPMENT, INC., a New York corporation, and DONALD L. BREN COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of September 30, 1981, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR-255230-1, No. RR-255230-2, No. RR-255230-3 and No. RR-255230-4, granting to said City easements for drainage and public street purposes affecting a portion of Parcel 1 of Parcel Map No. 11037, and a portion of Parcel 3 of Parcel Map No. 10518, all as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public streets is hereby dedicated as and for public streets, and the same is hereby named NOBEL DRIVE and LEBON DRIVE.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
