

RESOLUTION NUMBER R- 255244

Adopted on OCT 26 1981

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Pursuant to authority conferred by and in accordance with the provisions of California Vehicle Code sections 32 and 35701, the use of the following described streets be and it is hereby prohibited at all times to commercial vehicles of a gross vehicular weight rating of 2,000 pounds or more:


ESCALA DRIVE, between POMERADO ROAD and BERNARDO CENTER DRIVE; providing that this use limitation shall not apply to passenger buses or public utility vehicles under the jurisdiction of the Public Utilities Commission or commercial vehicles having a destination or point of origin on such street.

2. That the installation of the necessary signs and markings be and it is hereby authorized to be made on said streets.

3. That the regulations hereinabove imposed shall become effective upon the installation of such signs.
