One year's experience has shown a savings of \$3,876. This is the remainder of his award.
Raymond F. Fobert	Police	\$ 535	Mr. Fobert is a Police Sergeant. One year ago he earned a partial award of \$100 for his suggestion to discontinue completing the Field Interrogation Form for juvenile truant contacts. One year's experience has shown a savings of \$2,118. This is the remainder of his award.
Stephen E. Tallian	Planning	\$ 525	Mr. Tallian is a Graphics Supervisor. One year ago he earned a partial award of \$250 for his suggestion to discontinue the preparation of ownership maps for hearings and meetings. One year's experience has shown a savings of \$2,584.
