<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Albert D. Johnson	General Services	\$ 455	Mr. Johnson is a Senior Building Maintenance Supervisor in the Buildings Division. He suggested that compact trucks with commercial camper shells be purchased for the custodians rather than half-ton pick-up trucks. This saved the City \$4,544 in equipment and operating costs.
Thomas E. Trainor	Building Inspection	\$ 270	Mr. Trainor is an Electrical Inspection Supervisor. One year ago he earned a partial award of \$270 for his suggestion to make more efficient use of the floor area on the third floor of the City Operations Building. One year's experience has shown a savings of \$1,800. This is the remainder of his award.
John J. Jabson Steven Gates	General Services	\$ 215	Mr. Jabson and Mr. Gates are Equipment Mechanics in the Equipment Division. They suggested that a hole be drilled in the engine bellhousing, simplifying transmission operations. This is expected to save \$2,158 in the first year in labor costs.
Norma J. MacGregor Rachel A. Purdy	Police	\$ 190	Ms. MacGregor and Ms. Purdy are Intermediate Typists. One year ago they earned a partial award of \$75 for their suggestion to reduce the amount of typing on the Child Abuse cross reference cards. One year's experience has shown a savings of \$883. This is the remainder of their award.
Vincent DeLeva	General Services	\$ 175	Mr. DeLeva is an Electrical Supervisor in the Communications and Electrical Division. One year ago he earned a partial award of \$110 for his suggestion to reduce the lighting in the Zoo parking lot. One year's experience has shown a savings of \$2,835. This is the remainder of his award.
