That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Cynthia A. Robbins	Fire	\$ 85	Ms. Robbins is an Intermediate Typist. She suggested that the Fires Form be mailed as the final notice of a fire hazard, rather than typing individual letters. This is expected to save \$283 in the first year in labor costs.
Bradley H. Brown	Fire	\$ 65	Mr. Brown is a Fire Fighter. One year ago he earned a partial award of \$50 for his suggestion to combine the uniform incident report forms. One year's experience has shown a savings of \$931. This is the remainder of his award.
Jeffrey L. Frankhouser	General Services	\$ 50	Mr. Frankhouser is an Equipment Mechanic in the Equipment Division. He suggested that engine thermostats be modified to prevent blown engines. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Guy W. Walker	Property	\$ 50	Mr. Walker is a Property Agent. He suggested that the requirement for sublessees to furnish the City with a Certificate of Insurance be eliminated. Although savings were difficult to calculate, this was considered to be a significant operational improvement.
David R. Hughey	Water Utilities	\$ 50	Mr. Hughey is a Water Utilities Supervisor in the Systems Division. He suggested that cable riggings be utilized to lower and set water meter coffins. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
