Maureen Whelan Veronica Cole	General Services	\$ 30	Ms. Whelan is a Senior Clerk and Ms. Cole is an Auto Messenger in the Buildings Division. One year ago they earned a partial award of \$155 for their suggestion to produce computer printed mailing labels in zip code order. One year's experience has shown a savings of \$568. This is the remainder of their award.
Carol Harrison Priscilla Lindberg	General Services	\$ 30	Ms. Harrison is an Intermediate Typist and Ms. Lindberg is a Dispatch Clerk in the Equipment Division. One year ago they earned a partial award of \$90 for their suggestion to discontinue recording the condition of vehicles scheduled for auction. One year's experience has shown a savings of \$403. This is the remainder of their award.
W. Bronson Rideout	Building Inspection	\$ 25	Mr. Rideout is an Associate Structural Engineer. One year ago he earned a partial award of \$20 for his suggestion to establish a list of plan check engineers most familiar with plans submitted on a regular basis. One year's experience has shown a savings of \$157. This is the remainder of his award.
D. Gary Lee	Fire	\$ 25	Mr. Lee is a Fire Fighter. He suggested that quick disconnect clips be attached to both ends of the halyard on extension ladders. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Ronald H. Moskowitz	Fire	\$ 20	Mr. Moskowitz is a Fire Captain. He suggested that vehicle wheel blocks be modified to improve safety. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
