BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of VAN WATERS AND ROGERS is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing an ESTIMATED 100,000 LBS. OF HYDROGEN PEROXIDE as may be required for a period of one (1) year beginning November 1, 1981 through October 31, 1982 at a cost of \$0.339 per pound for a total cost of \$33,900.00; terms net 10th prox., plus sales tax, plus a tank installation charge of \$1,800.00; with an option to renew contract for an additional one (1) year period at prices not to exceed 15% of bid price.
