LEGAL DESCRIPTION

All that portion of Lot 43 of Rancho Mission of San Diego, in the County of San Diego, State of California, according to Partition Map on file in the Office of the County Clerk of San Diego County in Action No. 348 in Superior Court of said County entitled "Juan M. Luco et al versus The Commercial Bank of San Diego et al" being more particularly described as follows:

A strip of land 25.00 feet wide lying 15.00 feet Northerly and 10.00 feet Southerly of the following described line:

Commencing at the Southwest corner of Lot 3 of Rancho Mission Villas, according to Map thereof No. 8996 filed in the Office of said County Recorder; thence North  $15^{\circ}39'55''$  West along the Westerly line of said Lot 3, 58.95 feet; thence leaving said Westerly line South  $84^{\circ}20'46''$  West, 297.11 feet to a point in the Westerly line of Murphy Canyon Road as said street is located and established on August 19, 1981, said point also being the TRUE POINT OF BEGINNING; thence North  $63^{\circ}22'10''$  West, 93.28 feet to a point of terminus .

The sidelines of the above-described strip of land shall be prolonged or shortened to terminate Easterly in said Westerly line of Murphy Canyon Road and Westerly on the arc of a 4,071.50-foot radius curve, concave Westerly, a radial through said point of terminus bears North  $81^{\circ}36'14''$  East.
