

RESOLUTION NUMBER R- **255313**

APPROVING MAP OF SORRENTO CORPORATE PARK.

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that that certain map surveyed by PHILLIP S. BUTCHER, a Licensed Land Surveyor, entitled "SORRENTO CORPORATE PARK Being a subdivision of Lots 35, 36 and 37 of Sorrento Lands & Townsites, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 483, filed in the office of the County Recorder of San Diego County, February 9, 1888.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted, and said Council hereby accepts on behalf of the public the following: Lusk Boulevard, Corporate Park Avenue, Corporate Park Court and Sorrento Corporate Drive for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication those portions of Lots 3, 10 and 13, designated "Reserved for Future Street," as shown on this map, under the provisions of Section 66440 of the Government Code.


BE IT FURTHER RESOLVED, that said Council hereby accept on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water, drainage facilities and slopes, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over a portion of Lots 1, 2, 10, 11 and 12 and all of Lots 4 and 9, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; that said Council has rejected those portions of Lots 3, 10 and 13 designated "Reserved for Future Street,"; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities and slopes, together with the easement for open space, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
