
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of THE GREAT-WEST LIFE ASSURANCE COMPANY, a Canadian corporation, and TITLE INSURANCE AND TRUST, a California corporation, executed in favor of The City of San Diego, bearing date of August 18, 1981, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 255314, granting to said City an easement for public street purposes over, along and across a portion of Lot 9, in the Town of Sorrento, according to Maps thereof No. 362 and No. 483, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named LUSK BOULEVARD.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
