That the acceptance by the City Manager of that street easement deed of AVCO COMMUNITY DEVELOPERS, a California corporation, executed in favor of The City of San Diego, bearing date of August 25, 1981, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 255340, granting to said City the permanent easement and right of way to construct, reconstruct, maintain, operate and repair public roadways over, under, along and across a portion of Rancho San Bernardo as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named MATINAL ROAD.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
