
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of THE GREAT-WEST LIFE ASSURANCE COMPANY, a Canadian corporation, and TITLE INSURANCE AND TRUST, a California corporation, executed in favor of The City of San Diego, bearing dates of July 23 and August 7, 1981, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 255350, granting to said City a permanent easement and right of way in a portion of Parcels "A" and "B" of Lot 9, Sorrento Tract, Maps 362 and 483, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named VISTA SORRENTO PARKWAY.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
