That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with HERMAN KIMMEL & ASSOCIATES, INC., for professional engineering services in connection with the design of traffic signal and street lighting systems at six intersections, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 255355.

BE IT FURTHER RESOLVED, that the expenditure not to exceed \$17,000.00 from Capital Outlay Fund 30245, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program as follows: \$2,650 from CIP 62-203, Avenida de la Playa and La Jolla Shores Drive; \$3,250 from CIP 62-204, Barnett Avenue and Lytton Street; \$2,450 from CIP 62-215, Buenos Avenue and West Morena Boulevard; \$2,450 from CIP 62-211, College Avenue and Del Cerro Boulevard; \$2,450 from CIP 62-216, Euclid Avenue and Guymon Street; \$3,750 from CIP 62-213, Fairmount Avenue and Mission Gorge Road.
