A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPROVING AND ADOPTING THE CITY OF SAN DIEGO MARKS HISTORICAL REHABILITATION FINANCING PROGRAM AND DESIGNATING A CITY-WIDE HISTORICAL REHABILITATION AREA.

WHEREAS, The City of San Diego, a municipal corporation, (the "City") on October 6, 1981, adopted Resolution No. R- 255159 which approved in concept the establishment of a method to finance the rehabilitation of structures determined by the City to be of historical, architectural or cultural significance to the City pursuant to the Marks Historical Rehabilitation Act, (Health & Safety Code Section 37600 et seq.) (the "Marks Act"); and

WHEREAS, the City Council of the City has held two public hearings on Marks Act financing; and

WHEREAS, the City Council has designated a Citizen Advisory Board for the Marks Act process; and

WHEREAS, the Citizen Advisory Board has reviewed and approved a proposed City of San Diego Historical Rehabilitation Financing Program and recommended to the Council that such financing program be adopted by the City; and

WHEREAS, the Marks Act requires the designation of a historical rehabilitation area; and

WHEREAS, there are historical structures and historical sites scattered throughout the City of San Diego and it is, therefore, appropriate to designate all of the property in the City as being within a historical rehabilitation area; and


WHEREAS, City staff has reviewed and recommends approval of such program;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that:

1. The City of San Diego Marks Historical Rehabilitation Financing Program, a copy of which is on file in the office of the City Clerk as Document No. RR- 255365, is hereby approved and adopted.

2. All of the property within the City limits of the City of San Diego is hereby designated as a historical rehabilitation area for the purpose of implementing said Program.
