
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. BUTLER'S MILL, INC., 2. WILBUR ELLIS CO., 3. T & T DISTRIBUTING, 4. LOS ANGELES CHEMICAL COMPANY, and 5. SOUTHERN CALIFORNIA ORGANIC FERTILIZER CO. INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of FERTILIZERS, PESTICIDES, AND HERBICIDES, ETC. as may be required for a one (1) year period beginning December 1, 1981 through November 30, 1982, per prices on file in the Purchasing Department as follows:

1. BUTLER'S MILL, INC. for Items 1, 3, 4, 6, 9, 10, 12, 13, 14, 15, 17, 19, 20, 21, 22, 23, 24, and 25; terms 1% 20 days, plus sales tax, with an option to renew contract for an additional one (1) year period.
2. WILBUR ELLIS CO. for Items 5, 7, 8, 16, and 18, with a potential escalation of 15% during the contract period; terms net 10th prox, plus sales tax.
3. T & T DISTRIBUTING for Item 2, with a potential escalation of 15% during the contract period; terms net 30 days plus sales tax.
4. LOS ANGELES CHEMICAL COMPANY for Item 11, with a potential escalation of 15% during the contract period; terms net plus sales tax.
5. SOUTHERN CALIFORNIA ORGANIC FERTILIZER CO. INC. for Items 26 and 27, terms 2% 20 days, plus sales tax.
