BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Resolution No. R-254789 of August 10, 1981 be and it is hereby
amended to read as follows:

WHEREAS, the San Diego Padres played an exhibition game with the Oakland A's at San Diego Jack Murphy Stadium on Thursday, August 6, 1981 at which there was no charge for spectator admission; and

WHEREAS, the San Diego Padres played a regularly scheduled game with the

Atlanta Braves at San Diego Jack Murphy Stadium on Monday, August 10, 1981 at which there was no charge for spectator admission; and WHEREAS, the San Diego Padres have requested that City waive its policy with respect to Stadium use charges for the August 6, 1981 exhibition by imposing a rental charge to the Padres of \$1.00 plus the cost of maintenance, lighting, scoreboard and cleanup with concession revenues to be allotted to the Padres and parking revenues to be allotted to The City of San Diego; and

whereas, the San Diego Padres have requested that with respect to the game scheduled for August 10, 1981 that the provision of the agreement between The City of San Diego and the Padres providing that 8% of all ticket receipts be paid as rent be waived so that the 8% be computed only against season tickets, with other terms and conditions being that the Padres pay \$3,233.29, i.e., one-half of the cost of maintenance, lighting, scoreboard and cleanup for this event; and

WHEREAS, it apears that the waivers as above stated are in the best interest of the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows: That the City Manager be and he is hereby authorized to waive the payments and provide for use of the Stadium by the Padre's as set forth above.
