<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Debbie S. Coleman	Personnel	\$ 40	Ms. Coleman is a Senior Clerk. One year ago she earned a partial award of a Certificate of Merit for her suggestion to eliminate the use of the physical exam dates on payroll change notices. One year's experience has shown a savings of \$141. This is the remainder of her award.
Robert F. Hutchison	Park & Recreation	\$ 35	Mr. Hutchison is a Grounds Maintenance Worker in the Coastal Division. He suggested that steel barrels be used for trash containers on the Ocean Beach Pier. This is expected to save \$223 in the first year in material costs. This is a partial award pending a final 12-month review.
Donald E. Marx	Water Utilities	\$ 25	Mr. Marx is an Equipment Technician in the Water Quality Division. He suggested that mandatory classes in small engine maintenance and operation be established. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Myrna F. Choate	Risk Management	\$ 25	Ms. Choate was an Administrative Aide when she suggested that an Employee Personal Information form be utilized by all departments. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Joseph Liera	Water Utilities	\$ 25	Mr. Liera is an Equipment Technician in the Systems Division. He suggested that protective braces be installed on the aquaculture pools. Although savings were difficult to identify, this was considered to be a significant operational improvement.
