APPROVING MAP OF FASHION VALLEY CENTER.

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by ROBERT G. SCHOETTNER, a Licensed Land Surveyor, entitled "FASHION VALLEY CENTER Being a subdivision of a portion of Lot 1 of Fashion Valley, according to Map thereof No. 6170, filed in the office of the County Recorder of San Diego County, August 15, 1968, portions of Lots 7, 8 and 9 of E. W. Morse's Subdivision, according to Map thereof No. 103, filed in the office of the County Recorder of San Diego County, November 6, 1885, and a portion of Pueblo Lot 1105 of the Pueblo Lands of San Diego according to Map thereof by James Pascoe, a copy of which was filed in the office of the County Recorder of San Diego County, November 14, 1921, and is known as Miscellaneous Map No. 36, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council accepts on behalf of the public, the following: Friars Road, a portion of Camino de la Reina and the pedestrian and non-motor vehicular easement for public purposes, and said street, portion of a street and the pedestrian and non-motor vehicular easement are hereby declared to be a public street, a portion of a public street and a public pedestrian and non-motor vehicular easement and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts the easements with the right of ingress and egress for the construction and maintenance of water, drainage and electrical facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said street, portion of a street and the pedestrian and non-motor vehicular easement are accepted on behalf of the public as heretofore stated, and that those certain easements with the right of ingress and egress for the construction and maintenance of water, drainage and electrical facilities, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
