WHEREAS, certain drainage easements were acquired without cost for drainage purposes for the construction of Salmon River Road in Rancho Penasquitos now within the subdivision known as Penasquitos Park View Estates; and

WHEREAS, the present development of the property requires the quitclaim of the existing drainage easements; and

WHEREAS, the aforementioned drainage easements will no longer serve the public purpose for which they were acquired; and

WHEREAS, the City has no present or prospective public use for the drainage easements, and the City Manager has recommended that the City abandon its interests therein; and

WHEREAS, the drainage easements have a nominal value under the circumstances and GENSTAR DEVELOPMENT, INC. has paid all City costs in connection with processing the matter of quitclaiming the easements; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, on file in the office of the City Clerk as Document No. RR- 255455 - /, quitclaiming to GENSTAR DEVELOPMENT, INC., all the City's right, title and interest in the drainage easements, as more particularly described in said

quitclaim deed.
