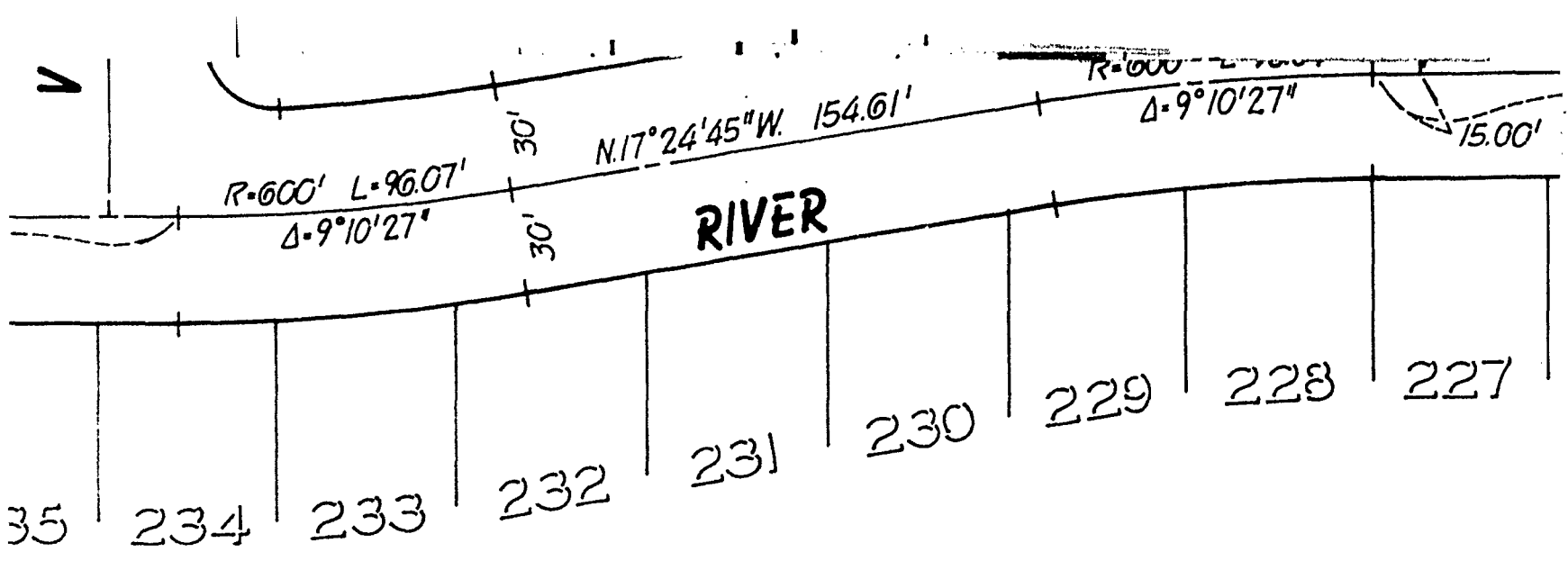


BASIS OF BEARINGS

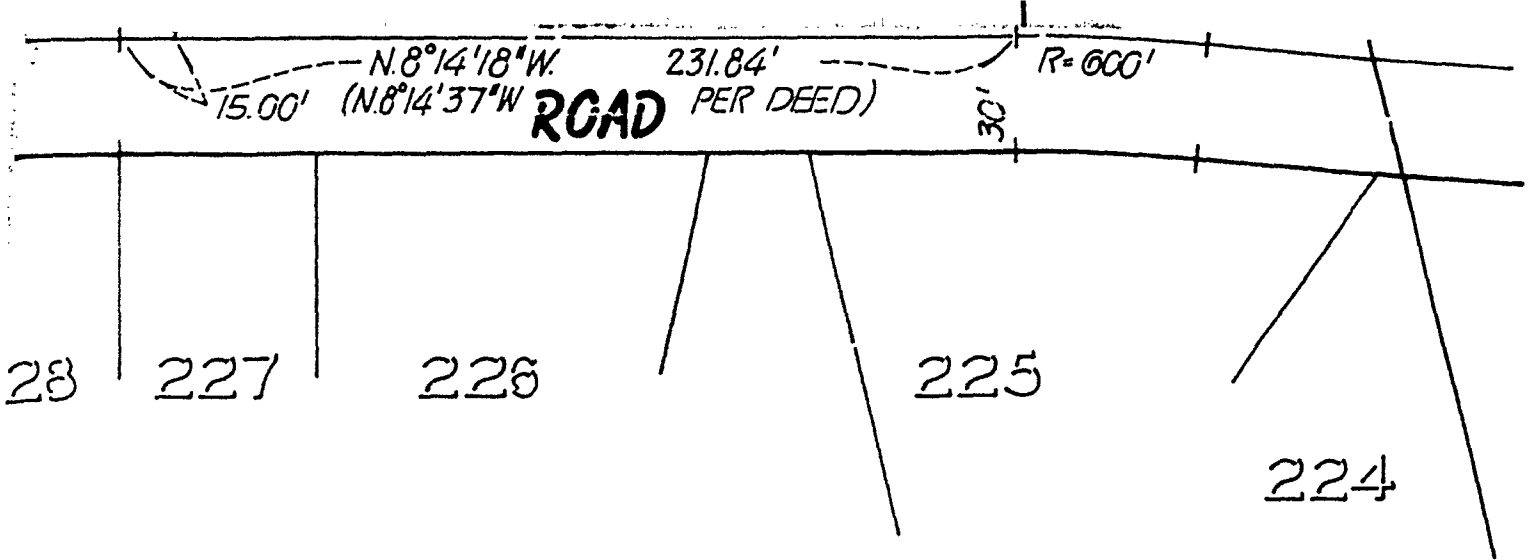



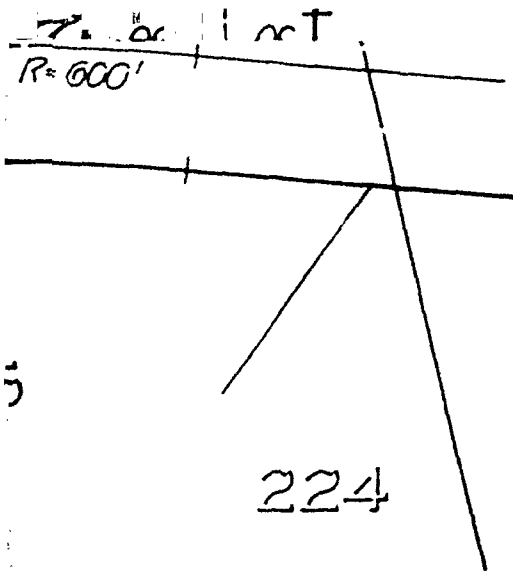
