

That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for underground and aboveground electrical facilities affecting Lots 7 through 10 in Block 26 of La Jolla Shores Unit 2, and Lots 9 through 11 in Block 31 of La Jolla Shores Unit 4, together with adjacent vacated portions of Calle Frescota and alley, to service the La Jolla Shores Lifeguard Station being constructed in Kellogg Park, as more particularly described in said deed on file in the office of the City Clerk as Document No. RR- 255457.
