RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, DIRECTING THE PURCHASING AGENT TO GIVE NOTICE INVITING SEALED BIDS FOR PROPOSALS FOR CONSTRUCTION WORK.

(SUNSET CLIFFS SHORELINE STABLIZATION ASSESSMENT DISTRICT)

WHEREAS, the Council of The City of San Diego, adopted its Resolution of Intention, Resolution No. R-255465, declaring its intention to oder the work and improvements therein referred to; and

WHEREAS, it is desirable to obtain bids and proposals prior to ordering the work and improvements, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Sealed bids and proposals for the work and improvements hereinafter described shall be invited and received in the manner as provided by law.

2. The Purchasing Agent of the City of San Diego is hereby declared to be the officer to whom bids and proposals for such work and improvements shall be delivered and presented.

3. The Purchasing Agent of the City of San Diego is hereby directed to post, publish and otherwise give notice inviting such bids and proposals substantially in the form of Exhibit "A" attached hereto, and incorporated by reference herein, in the manner as provided by law.

drawings, and estimates are hereby referred to for a descrip-
tion of the work and improvements, the grades to which, and
rights-of-way and other places within which it is to be done, a
description of the district to be assessed to pay the cost and
expenses thereof, and for all further particulars.

NOTICE IS FURTHER GIVEN that the Council has ascertained and declared by the adoption of Resolution No. R-251555 on April 7, 1980, and on file in the office of the City Clerk, the prevailing rate and scale for wages in accordance with law to be paid in the construction of the above-entitled improvements. Said rates and scales are by reference incorporated herein and made a part of this notice.

The City Council reserves the right to reject any and all bids and proposals, and to the extent permitted by law, to waive any irregularity in any bid or proposal.

Each bid or proposal shall be accompanied by cash, or a check payable to the order of the City of San Diego certified by a responsible bank, or a cashier's check, for an amount not less than 10% of the aggregate of the proposal, or a bond as required by Section 10502 of the Streets and Highways Code.

The bids and proposals shall be presented to the Purchasing Agent of the City of San Diego at his office in City Operations Building, 1222 First Avenue, in the City of San Diego, on or before 11:00 a.m. on January 27, 1982.

Bids and proposals will be opened by the Purchasing Agent at a public meeting in Conference Room on the Fifth Floor of the said City Operations Building, at the hour of 11:00 a.m.


