Adopted on DEC 8 1981

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Condition No. 22 of Subdivision Board Resolution No. 2245, approved on March 12, 1980, regarding park fees in Pueblo Del Rio subdivision, T.M. 76-217, be and it is hereby deleted.

BE IT FURTHER RESOLVED, that said amendment be adopted with the condition that owner and developer pay \$120,00.00 in park fees, at least \$39,000.00 in cash and the remaining \$81,000.00 in cash or services equal to or more than that sum. The terms and conditions of said payment of park fees shall be negotiated with City staff and an agreement entered into at the time of the final map.
