WHEREAS, the City of San Diego has encouraged the redevelopment of the Centre City area; and

WHEREAS, the Redevelopment Agency of the City of San Diego ("Agency") has undertaken certain redevelopment projects in the Centre City area including the improvement of Pantoja Park; and

WHEREAS, the City has made application for fourth year funding of the Roberti-Z'berg Urban Open Space and Recreation Program Act and has received an advance of said funding designated for Pantoja Park; and

WHEREAS, the Agency has received and budgeted other funds, such as developer contributions, Park Service District funds and Capital Improvement funds, to be utilized for the improvement and expansion of Pantoja Park.

NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. That the City Council hereby authorizes and approves the expenditure of:
  - (a) The State's advance of \$93,311 (90%), and, when received from the State, \$10,367 (10% upon completion of the project) along with all interest which has accrued since receipt of these monies from the State of California; and
  - (b) \$33,450 in Building Permit funds (Fund No. 15580);

by the Redevelopment Agency solely for the improvement of Pantoja Park.

2. That in the event that the Agency desires to issue bonds, notes, or other instruments of indebtedness of the Agency to carry out these redevelopment projects, then any indebtedness of the Agency to the City, including any interest accrued thereon, shall be deemed not to be a first pledge of tax increment allocations received by the Agency pursuant to the Health and Safety Code, Section 33670; and any indebtedness of the Agency of the City, including any interest accured thereon shall be subordinated to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.


