That the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, an agreement with the firm of MARK BRIGGS & ASSOCIATES, INC. to provide consultant services to the City in reviewing and processing Urban Development Action Grant (UDAG) applications, a copy of which agreement is on file in the office of the City Clerk as Document No. RR- 255505.


BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$15,000 for said consultant services is hereby authorized.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to establish a special fund 19615 to account for those contributions.

BE IT FURTHER RESOLVED, that the transfer of \$5,000 from the Barrio Logan North Industrial Park, Fund 18516, Dept. 5969, Org. 6903, to Fund 18516, Dept. 5969, Org. 6907, for the City's portion of consultant costs is hereby authorized and approved.
