

RESOLUTION NUMBER R- 255519

Adopted on DEC 15 1981

WHEREAS, the Planning Commission has reviewed proposed amendments to the Progress Guide and General Plan, General Plan Map, Phased Development Areas Map, Open Space Map; and Community Planning Areas Map to reflect the adopted and amended Rancho Carmel Community Plan, Otay Mesa Community Plan, Otay Mesa-Nestor Community Plan, Mira Mesa Community Plan, Rancho Bernardo Community Plan, and La Jolla Shores Precise Plan; and

WHEREAS, the Planning Commission has reviewed proposed amendments to the Progress Guide and General Plan, General Plan Map, Open Space Map, Phased Development Areas Map, and Community Planning Areas Map to reflect changes in the boundaries of the City of San Diego resulting from the approved Kaiser-Mission Gorge Annexation and Santee City Detachments; and

WHEREAS, the Planning Commission has reviewed proposed amendments to the Progress Guide and General Plan, General Plan Map, and Open Space Map to reflect the acquisition of open space lands by public agencies; and

WHEREAS, the Planning Commission has reviewed proposed amendments to the Progress Guide and General Plan Introduction regarding population, housing and land use data to reflect the 1980 U. S. Census and the Regional Growth Forecasts, Series V; and

WHEREAS, the Planning Commission has reviewed proposed

amendments to the Progress Guide and General Plan Guidelines for Future Development regarding Prospective Annexation Areas to reflect City Council Policy No. 600-1; and

WHEREAS, the Planning Commission has reviewed proposed amendments to the Progress Guide and General Plan, General Plan Map, Industrial Map and Industrial Element Inventory to designate certain Pueblo Lands located in the University Community Plan area as General Industry, and to reflect community plan land use designations; and

WHEREAS, the Planning Commission conducted a public hearing on said proposed amendments on November 5, 1981; and

WHEREAS, the Planning Commission recommended City Council approval of said proposed amendments; and

WHEREAS, the City Council conducted a public hearing on said proposed amendments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


