
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and drainage easement deeds of ROBINHOOD HOMES, INC., a California corporation, and SURF VIEW DEVELOPMENT CO. and EUGENE B. FLETCHER, INC., executed in favor of The City of San Diego, bearing dates of October 6 and October 12, 1981, respectively, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 255526-1 , RR- 255526-2 and RR- 255526-3 , granting to said City easements for storm drains and public street purposes, in Lot 1, Dairy Mart International, Map No. 7595, and portions of Section 35, Township 18 South, Range 2 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named SERVANDO AVENUE.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
