RESOLUTION NUMBER R- 255550

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires that federal allocations for housing assistance programs be consistent with housing assistance goals stated in the Housing Assistance Plan (HAP); and

WHEREAS, the goals in the current HAP for large families in the Moderate Rehabilitation Program will not accomodate the 76 3- and 4-bedroom units in the Del Sol project; NOW, THEREFORE,

BE IT RESOLVED, that the large family annual and three year goals for the Moderate Rehabilitation Program be increased from 17 to 27 and 50 to 80 respectively and the small family annual and three year goals be decreased from 244 to 233 and 730 to 700 respectively.
