WHEREAS, the City of San Diego, as a CETA prime sponsor, currently formed a consortium with the County of San Diego to administer manpower programs in this region; and

WHEREAS, under regulations and legislation which will be promulgated by the federal government in the near future it may not be advantageous to the City of San Diego to participate in such a consortium; and

WHEREAS, it is necessary to submit a "Preapplication for Federal Assistance" at this time to protect the City's right to withdraw from the consortium; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized to submit a "Preapplication for Federal Assistance" to the United States Department of Labor to reserve the right for the City of San Diego to operate CETA programs conducted within the City limits in Federal Fiscal year 1983.
