AN ORDINANCE AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH THE SAN DIEGO UNIFIED SCHOOL DISTRICT FOR THE USE, DEVELOPMENT AND MAINTENANCE OF A PORTION OF THE CABRILLO ELEMENTARY SCHOOL SITE FOR PARK AND RECREATION PURPOSES FOR A TERM OF TWENTY-FIVE YEARS.
