ORDINANCE NUMBER O- 15651 (New Series)

Adopted on JAN 18 1982

AN ORDINANCE INCORPORATING LOT 1, LINDQUIST AND THOMPSON SUBDIVISION, MAP 5371 (APPROXIMATELY 40,075 SQ. FT.), LOCATED NORTH OF OTHELLO STREET, EAST OF CONVOY STREET, IN THE SERRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B ZONE, AS DEFINED BY SECTION 101.0435.2 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8978 (NEW SERIES), ADOPTED MARCH 12, 1964, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:


Section 1. That Lot 1, Lindquist and Thompson Subdivision, Map 5371 (approximately 40, 075 sq. ft.), located north of Othello Street, east of Convoy Street, in the Serra Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "M-1B" on Zone Map Drawing No. B-3485, be, and it is hereby incorporated into M-1B Zone, as such zone is described and defined by Section 101.0435.2 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8978 (New Series), adopted March 12, 1964, of the ordinances of The City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application

therefor was made prior to the date of adoption of this ordinance.
