AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 7 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0763, RELATING TO ADVERTISING DISPLAY AREAS.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter X, Article 1, Division 7, of the San Diego

Municipal Code be, and it is hereby amended by amending Section 101.0763 to

read as follows:

SEC. 101.0763 ADVERTISING DISPLAY AREAS ("AD AREAS") DEFINED AND ESTABLISHED.

AD Areas are areas which are imposed upon legally described portions of the City which are zoned C-1S, C-1, CS, C, M-1A, M-1, or M-2, or any combination thereof, for the purpose of permitting off-premises outdoor advertising displays which may be utilized only within said areas. Off-premises outdoor advertising displays shall not be permitted to be erected outside any such designated area.

Advertising displays shall be permitted within AD areas provided those areas are zoned C-1S, C-1, CS, C, M-1A, M-1, or M-2, at the time the application for a building permit for the advertising display is submitted. No advertising display shall be permitted in any area designated "AD" on the following drawings if the underlying zone has been changed to any zone other than those commercial and industrial zones listed in this section.
