AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 7, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 67.56, RELATING TO WATER RATES - GENERAL WATER SERVICE OUTSIDE THE CITY OF SAN DIEGO.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter VI, Article 7, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 67.56 to read as follows:

SEC. 67.56 WATER RATES - GENERAL WATER SERVICE OUTSIDE THE CITY OF SAN DIEGO

The rates to be charged and collected for water supplied in any one month for Domestic, Commercial and Industrial use outside the City, and for all purposes for which no other rate for water supplied for use outside the City is provided in this Article, shall be the amount computed at the rates set forth in Section 67.55 of this Code as adjusted by Section 67.59.1 of this Code multiplied by 2.00; provided, however, that the rates to be charged and collected for water supplied for Agricultural use outside the City shall be computed at the rates set forth in Section 67.55 as adjusted by Section 67.59.1.

Nothing contained in this section shall be construed to change or modify any existing legal contracts or obligations between the City of San Diego and any person, firm or corporation as to the rate or rates for water or the obligations in connection therewith.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

Nothing contained in this section shall be construed to change or modify any existing legal confracts or obligations between the City of San Diego and any person, firm or corporation as to the rate or rates for water or the obligations in connection therawith.

Section 2. This ordinance shall take effect and be in force on thirtieth day from and after its passage. Introducted on February 16, 1982.
