AN ORDINANCE SETTING ASIDE AND DEDICATING A PORTION OF THE SOUTHWEST QUARTER OF PUEBLO LOT 1210 OF THE PUEBLO LANDS OF SAN DIEGO, TOGETHER WITH PORTIONS OF LOTS 3 AND 4 OF THE SUBDIVISION OF PUEBLO LOT 1207, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of the Southwest Quarter of Pueblo Lot 1210 of the Pueblo Lands of San Diego, together with portions of Lots 3 and 4 of the Subdivision of Pueblo Lot 1207, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

Said real property lies Southerly of the Southerly property line of Marston Junior High School, as granted to the San Diego Unified School District by deed recorded in the San Diego County Recorder's Office, April 28, 1952, Document No. 51359, Book 4447, Page 521 of Official Records; Northerly of the Northerly property lines of Whittier Elementary School, as granted to the San Diego Unified School District by deed recorded in the San Diego County Recorder's Office, April 28, 1952, Document No. 51364, Book 4447, Page 550 of Official Records; Easterly of the Easterly right-of-way line of Clairemont Drive, as now located and established; and Westerly of the Westerly right-of-way line of Waco Street, as now located and established.
