AN ORDINANCE SETTING ASIDE AND DEDICATING LOT 438 OF CLAIREMONT PARK UNIT NO. 2, TOGETHER WITH A PORTION OF PUEBLO LOT 1205 OF THE PUEBLO LANDS OF SAN DIEGO, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:



That Lot 438 of Clairemont Park Unit No. 2, together with a portion of Pueblo Lot 1205 of the Pueblo Lands of San Diego, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
