AN ORDINANCE SETTING ASIDE AND DEDICATING BLOCKS 6, 8, 10 AND 12 OF LA BINDA PARK, TOGETHER WITH PORTIONS OF FORMER PALM, HOLLY, VINE, AND IVY COURTS, AND 29TH STREET, NOW VACATED AND CLOSED TO PUBLIC USE, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Blocks 6, 8, 10, and 12 of La Binda Park, together with portions of former Palm, Holly, Vine, and Ivy Courts, and 29th Street, now vacated and closed to public use, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

PARCEL 17
(Memorial Community Park)

All of Blocks 6, 8, 10, and 12 of La Binda Park, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1538, filed in the Office of the San Diego County Recorder, March 5, 1913; together with those portions of former Palm, Holly, Vine, and Ivy Courts, now vacated and closed to public use, lying between the East and West boundaries of Blocks 4, 6, 8, 10, and 12 of said La Binda Park; also including the East Half of former 29th Street, now vacated and closed to public use, the sidelines of which terminate Northerly in the Southerly line of Ocean View Boulevard and terminate Southerly in the Northerly line of Marcy Avenue, as said streets are now located and established.

EXCEPTING FROM Block 12 those portions, if any, previously dedicated as public streets.
