AN ORDINANCE SETTING ASIDE AND DEDICATING LOTS 32, 33 AND 34 OF SOUTHERN TITLE GUARANTY COMPANY'S SUBDIVISION OF PUEBLO LOT 1801; A PORTION OF PUEBLO LOT 256, TOGETHER WITH PORTIONS OF ELECTRIC LINE ADDITION AND SELLOR'S ADDITION; PORTIONS OF PUEBLO LOTS 274, 279, AND 280, TOGETHER WITH PORTIONS OF CITY GARDENS AND ADDITION NO. 1 TO CITY GARDENS; LOTS 54, 55, 56, AND 57, AND PORTIONS OF LOTS 52, 53, 58, 59 AND 60 IN BLOCK 103 OF OCEAN BAY BEACH, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 32, 33, and 34 of Southern Title Guaranty Company's Subdivision of Pueblo Lot 1801; a portion of Pueblo Lot 256, together with portions of Electric Line Addition and Sellor's Addition; portions of Pueblo Lots 274, 279, and 280, together with portions of City Gardens and Addition No. 1 to City Gardens; Lots 54, 55, 56, and 57, and portions of Lots 52, 53, 58, 59, and 60 in Block 103 of Ocean Bay Beach, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

- B.
