PARCEL 33

(Tierrasanta Community Park)

All that portion of Lot 15 of Rosedale Tract, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 825, filed in the Office of the County Recorder of San Diego County, January 21, 1897, more particularly described as follows:
