ORDINANCE NUMBER O- 15733 (New Series)

AN ORDINANCE PREZONING PORTIONS OF SECTIONS 4, 5 AND 9, TOWNSHIP 14 SOUTH, RANGE 3 WEST, S.B.B.M., AND A PORTION OF RANCHO SAN DIEGUITO ACCORDING TO MAP NO. 1 (APPROXIMATELY 279.4 ACRES), LOCATED SOUTH OF VIA DE LA VALLE ONE MILE EAST OF I-5, IN THE COUNTY OF SAN DIEGO, CALIFORNIA, INTO A-1-10, A-1-10(FPF) AND FW ZONES, AS DEFINED BY SECTION NOS. 101.0404, 101.0403.1 AND 101.0403, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That portions of Sections 4, 5 and 9, Township 14 South, Range 3 West, S.B.B.M. and a portion of Rancho San Dieguito according to Map No. 1 (approximately 279.4 acres), located south of Via de la Valle one mile east of I-5, in the County of San Diego, California, within the boundaries of the districts designated "A-1-10," "A-1-10(FPF)" and "FW" on that certain Zone Map Drawing No. B-3477, filed in the office of the City Clerk under Document No. RR-768366 be, upon annexation to The City of San Diego, incorporated into A-1-10, A-1-10(FPF) and FW Zones as defined by Section Nos. 101.0404, 101.0403.1 and 101.0403, respectively, of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, or the effective date of annexation, whichever is later.
