AN ORDINANCE SETTING ASIDE AND DEDICATING A PORTION OF PUEBLO LOT 206 OF THE PUEBLO LANDS OF SAN DIEGO, TOGETHER WITH PORTIONS OF LOTS 7 AND 8 IN BLOCK 8 OF LOMA ALTA NO. 1, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That a portion of Pueblo Lot 206 of the Pueblo Lands of San Diego, together with those portions of Lots 7 and 8 in Block 8 of Loma Alta No. 1, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

PARCEL 4  
(Collier Community Park)

- A. All that portion of Pueblo Lot 206 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the Office of the San Diego County Recorder, November 14, 1921, as Miscellaneous Map No. 36, more particularly described as follows:

Commencing at the Easterly corner of said Pueblo Lot 206; thence South  $36^{\circ}07'01''$  West, 1,320.85 feet; thence North  $53^{\circ}53'35''$  West, 194.85 feet; thence North  $53^{\circ}51'38''$  West, 175.83 feet to the TRUE POINT OF BEGINNING; thence North  $63^{\circ}36'26''$  East, 199.62 feet; thence North  $14^{\circ}45'02''$  West, 1,236.78 feet; thence North  $36^{\circ}06'28''$  East, 310.21 feet (Deed); thence North  $53^{\circ}53'32''$  West, 338.81 feet; thence North  $53^{\circ}52'44''$  West, 7.00 feet; thence South  $36^{\circ}10'15''$  West, 541.34 feet (Record: 541.18 feet); thence North  $21^{\circ}13'48''$  West, 437.78 feet (Record: 437.45 feet); thence South  $36^{\circ}07'21''$  West, 52.34 feet; thence North  $53^{\circ}52'39''$  West, 30.00 feet; thence South  $36^{\circ}07'21''$  West, 17.51 feet; thence South  $21^{\circ}13'48''$  East, 1,289.04 feet to the beginning of a 5,100.00-foot radius curve, concave Southwesterly, a radial to said point bears North  $68^{\circ}46'12''$  East; thence Southerly along the arc of said curve through a central angle of  $03^{\circ}54'07''$ , an arc length of 346.80 feet; thence South  $53^{\circ}51'38''$  East, 237.05 feet returning to the TRUE POINT OF BEGINNING. ALSO:

- B. All that portion of Lots 7 and 8 in Block 8 of Loma Alta No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1078, filed in the Office of the San Diego County Recorder, January 17, 1917, lying Northwesterly of the Northwesterly line of Famosa Boulevard, as said boulevard is now located and established.

EXCEPTING FROM Parcels A and B those portions, if any, previously dedicated as public streets.

(Basis of bearings: centerline of Nimitz Boulevard as shown on 8291-L, i.e., North  $21^{\circ}13'48''$  West derived from the Northeasterly line of Point Loma Heights, Map 1106).
